TENDER NOTICE

Sealed Tenders are hereby invited on behalf of the Governor of Mizoram from reputed and bonafide Manufacturers or their authorized dealers, for **Rate Contract of Hospital Linen & Clothing** which will be received by the Director, Hospital & Medical Education, Mizoram , Aizawl on or before **15th December, 2011 upto 12:00 Noon** under the terms and conditions laid down below. Quotations are to be opened by Director, Hospital & Medical Education, Mizoram, Aizawl or his authorized representatives at **1:00 Pm** on the same day. The Tenderers or their representatives may also be present at the time of opening of the Quotations, if they so desire.

TERMS & CONDITIONS

1. Tenders should be submitted in the prescribed form only.
2. Earnest Money should accompany tenders. Rs. 16,000/- in case of Non-Tribal, and Rs 8,000/- in the case of Tribal Tenders in the form of Deposit at Call/ Fixed Deposit in original, from any Nationalized Bank of India or Postal Saving Certificate duly pledged in favor of Director, Hospital & Medical Education , Mizoram, Aizawl.
3. Tenders should be submitted in duplicate marked "Original" and "Duplicate" on the cover envelope. The cover of the tenders should be super scribed as **Tender for Rate Contract of Hospital Linen & Clothing** addressed to Director, Hospital & Medical Education, Government of Mizoram, Aizawl and clearly indicate full postal address of the tenderer.
4. Non-Tribal tenderer should affix a Non-Judicial Court Fee Stamp worth at least Rs. 7.50/- and Photo copy of valid sales Tax/VAT Registration up to the latest year for which assessment has been made by the concerned authority and duly attested by a Gazette Officer or Notary. Original Certificate should be produced at the time of opening, if demanded.
5. The tribal tenderer should furnish attested copy of Tribal Certificate issued by the competent authority. Original Certificate should be produced at the time of opening, if demanded.
6. All pages of the tender papers should be printed, signed, stamped and dated. Any page or pages not signed, stamped and dated are liable to be rejected. Correction, if any, should be initialed, stamped and dated.

7. Tenderers should quote their rates in terms of Indian Rupees and should be quoted inclusive of all taxes and duties which should clearly be mentioned in the quotation.
8. Tenderers should quote their rates F.O.R Central Medical Store, Zemabawk.
9. If any tenderer violates or fails to fulfill any one of the clauses, his or her tender are liable to be rejected at the time of opening the tender.
10. Once the rate is accepted and communicated to the successful firm, the same will remain valid during the validity period of the agreement with the approved supplier and no price escalation will be permissible during the validity period, which is normally for a period of 12 months and is extendable, if mutually agreed upon by both the parties i.e. the Health & Family Welfare Department and concerned approved supplier, subject to recommendation of the State Purchase Advisory Board or the Departmental Purchase Advisory Board, as the case may be.
11. A successful firm will have to supply the materials within the period fixed by the Department/Authority. If the supply cannot be made within the stipulated period without any intimation, supply order shall be treated as cancelled and the Department shall have the right to procure the materials from any other sources and the differences in prices, if any, will be realized from the Security Deposit of the approved supplier, as mentioned herein, without assigning any reason thereof.
12. A successful firm will have to furnish Security Deposit of 5% of the value of the supply before issue of supply order in the form of Demand Draft/Fixed Deposit in any Nationalized Bank of India or Postal Saving Certificate, as the case may be, duly pledged in favor of Director, Hospital & Medical Education, Government of Mizoram, Aizawl.
13. A successful firm will have to execute an appropriate Deeds of Agreement within 15 days from the date of issue of acceptance of their quoted rates failing which their firms will be treated as invalid tender.
14. The undersigned shall not be bound to accept the lowest rate or any of the tenders and reserves the right to accept or reject any tenders without assigning any reason thereof.
15. In case of any legal disputes/litigations arising out of this Tender Notice or its terms, the Courts of Law at Aizawl only shall have jurisdiction to adjudicate the same.
16. All payments will be made only after the materials are received in full and good condition by Vigilance Committee.

17. Any attempts for negotiation/campaign, direct or indirect, on the part of a tender with the authority to whom he has submitted the Tender or the authority who is competent to accept, shall render such Tender liable to be excluded from consideration, if proved.
18. Late/delayed tenders will not be entertained. Certificates other than those stated in the above clauses shall be rejected straightaway. Any other/further clarifications in connection with submission of the tender may be made from the office of Director, Hospital & Medical Education, Mizoram during office hours on all working days.
19. All bidders should submit samples of each item except **Sl. 2 (Matress Rubberised Coir)** alongwith the quotation.
