TENDER NOTICE

Sealed Tenders are hereby invited on behalf of the Governor of Mizoram from reputed and bonafide Manufacturers or Authorized Distributors, Stockists or Agents for **Rate Contract of Mammography/X-Ray/C.T Scan Film and Chemicals for a period of one year** which will be received by the Director, Hospital & Medical Education, Mizoram, Aizawl on or before **9th December 2011 upto 12 Noon** under the terms and conditions laid down below. Quotations are to be opened by Director, Hospital & Medical Education, Mizoram, Aizawl or his authorized representatives at **1:00 Pm** on the same day. The Tenderers or their representative may also be present at the time of opening of the Tender, if desire.

TERMS & CONDITIONS

1. Firms and Individuals who are not Authorized Distributors, Stockists or Agents but only authorized to quote their rates on behalf of the manufacturers, Distributors, Stockist or Agents shall not be accepted as Authorized Distributors, Stockists or Agents. Sub-Distributors, Sub-Stockists or Sub-Agencies shall not be considered.
2. Authorized Distributors/Stockist or agents should furnish Photo copy of their Distributorship or Stockist or Agencies Certificate duly attested by a Gazzeted Officer or Notary and should produce Original Certificate at the time of opening the tender, if demanded.
3. Tenders should be submitted in the prescribed form only which can be obtained from the office of Directorate of Hospital & Medical Education, Mizoram, Aizawl on working days.
4. Tenders should be submitted in duplicate marked "Original" and "Duplicate" on the cover envelope. The cover of the tenders should be super scribed as **"Tender for Rate Contract of Mammography / X-Ray / C.T Scan Film and Chemicals for a period of one year"** addressed to Director, Hospital & Medical Education, Government of Mizoram, Aizawl and should clearly indicate full postal address of the tenderer.
5. Non-tribal tenderer should affix a Non- Judicial Court Fee Stamp worth at least Rs.7.50/- and should furnish Original copy of valid Sales Tax/VAT Clearance Certificate up to the latest year for which assessment has been made by the concerned authority and duly attested by a Gazetted Officer or Notary. Original Certificate should be produced at the time of opening, if demanded.
6. The tribal tenderer should furnish attested copy of Tribal Certificate and MVAT Registration issued by the competent authority. Original Certificate should be produced at the time of opening, if demanded. Original MVAT Clearance Certificate for which further assessment has been made by the competent authority up to the latest year should be attached.

7. Tenders should be accompanied with the Earnest Money Deposit of Rs. 16,000/- in case of Non-Tribal, and Rs 8,000/- in the case of Tribal Tenders in the form of Demand Draft/Deposit at Call in original, from any Nationalized Bank of India or Postal Saving Certificate duly pledged in favor of Director, Hospital & Medical Education , Mizoram, Aizawl.
8. Manufacturers submitting their tenders should attach Photo copy of their Manufacturing License duly attested by a Gazette Officer or Notary. Original Certificate should be produced at the time of opening, if demanded.
9. Tenderer should quote their rates in terms of Indian Rupees. Rate should be quoted inclusive of all taxes and duties and should be mentioned clearly in the quotation.
10. Tenderer should quote their rates F.O.R Destination.
11. If any tenderer violates or fails to fulfill any one of the clauses, his or her tender are liable to be rejected at the time of opening the tender.
12. A successful firm will have to supply the materials within the period fixed by the Department/Authority. If the supply cannot be made within the stipulated period without any intimation, supply order will be treated as cancelled. The Department shall have the right to procure the materials from any other sources and the differences in prices, if any, will be realized from the Security Deposit of the approved supplier, as mentioned herein, without assigning any reason thereof.
13. A successful firm will have to furnish Security Deposit of 5% of the value of the supply before issue of supply order in the form of Demand Draft/Fixed Deposit in any Nationalized Bank of India or Postal Saving Certificate, as the case may be, duly pledged in favor of Director, Hospital & Medical Education, Government of Mizoram, Aizawl.
14. A successful firm will have to execute an appropriate Deeds of Agreement within 7 days from the date of issue of acceptance of their quoted rates failing which the firm will be treated as invalid tenderer.
15. The undersigned shall not be bound to accept the lowest rate or any of the tenders and reserves the right to accept or reject any tenders without assigning any reason thereof.
16. Late/delayed tenders will not be entertained. Certificates other than those stated in the above clauses should not be attached. Any other/further clarifications in connection with submission of the tender may be made from the office of Director, Hospital & Medical Education, Mizoram during office hours on all working days.
17. In case of any legal disputes/litigations arising out of this Tender Notice or its terms, the Courts of Law at Aizawl only shall have jurisdiction to adjudicate the same.

18. All payments will be made only after the materials are received in full and in good condition by Vigilance Committee. Part payment will not be entertained.
19. Any attempts for negotiation/campaign, direct or indirect, on the part of a tender with the authority to whom he has submitted the Tender or the authority who is competent finally to accept, shall render such Tender liable to be excluded from consideration, if proved.
